



Credit transfer guide

[The ECTS \(European Credit Transfer System\)](#) is used across all European Union countries.

Validation of one semester requires completion of at least 30 ECTS, while validation of a full academic year requires completion of at least 60 ECTS.

The ECTS system, however, is not commonly used outside the European Union.

For non-European institutions not using the ECTS system, ISIT has worked with its partners to define equivalences (in terms of local credits or workload).

For some non-European partner institutions, however, no equivalence can be determined. For these institutions, the ISIT heads of language departments help students choose suitable and sufficient courses for their academic exchange.
